

RE: AMENDING THE 2024 ANNUAL BUDGET FOR THE PURPOSE OF FUNDING THE PURCHASE AND INSTALLATION OF THE UTILITY BILLING KIOSK AT THE NIXA COMMUNITY LIBRARY

Background:

Last December, City Council approved \$12,000 for the addition of utility billing kiosks at the Library and City Hall. The reason for this line-item was to expand the number of ways Nixa residents can pay their utility bills. One kiosk is currently in operation inside the XCenter.

Analysis:

Supporting documents are attached below.

I was tasked with putting together pricing to get a unit installed outside the Nixa Community Library. While coordinating with Dynatouch, it was determined that an enclosure would be needed to protect the unit from the elements. Staff got in touch with Sterling ATM to come up with a design for the kiosk enclosure. Staff also plans to utilize a Job Order Contract with Hambey Construction to purchase and install the unit. Approval of that contract will be at the next council meeting.

Staff is requesting a budget amendment to the water fund for \$22,000. This is on top of the \$12,000 previously approved. This will fund the purchase of the enclosure, a clearance sign, shipping costs, installation costs, camera system, concrete pad & bollards, electrical work, graphic design, and our annual lease agreement with the library.

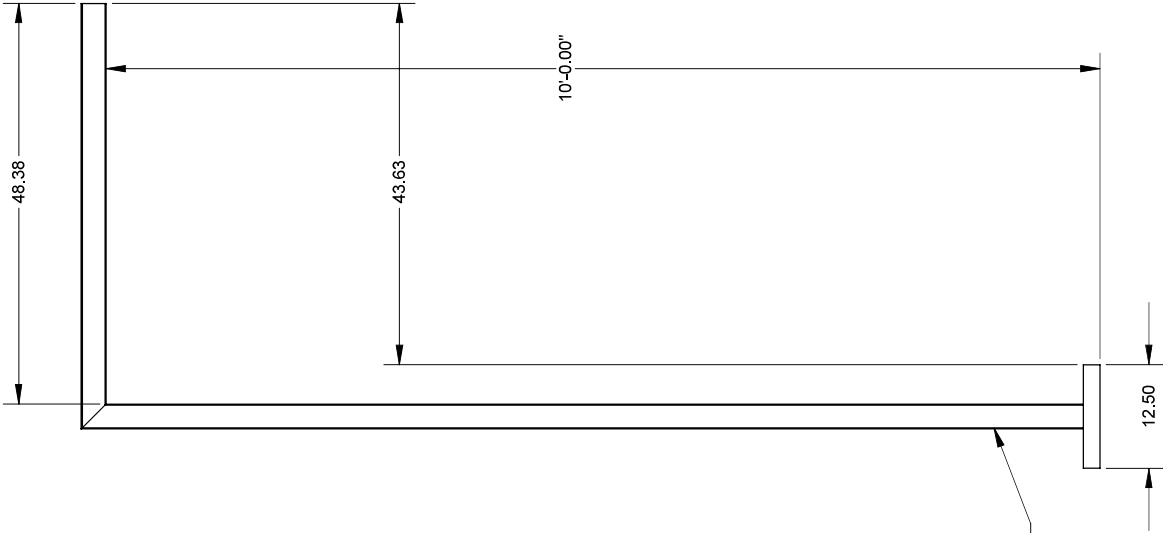
Recommendation:

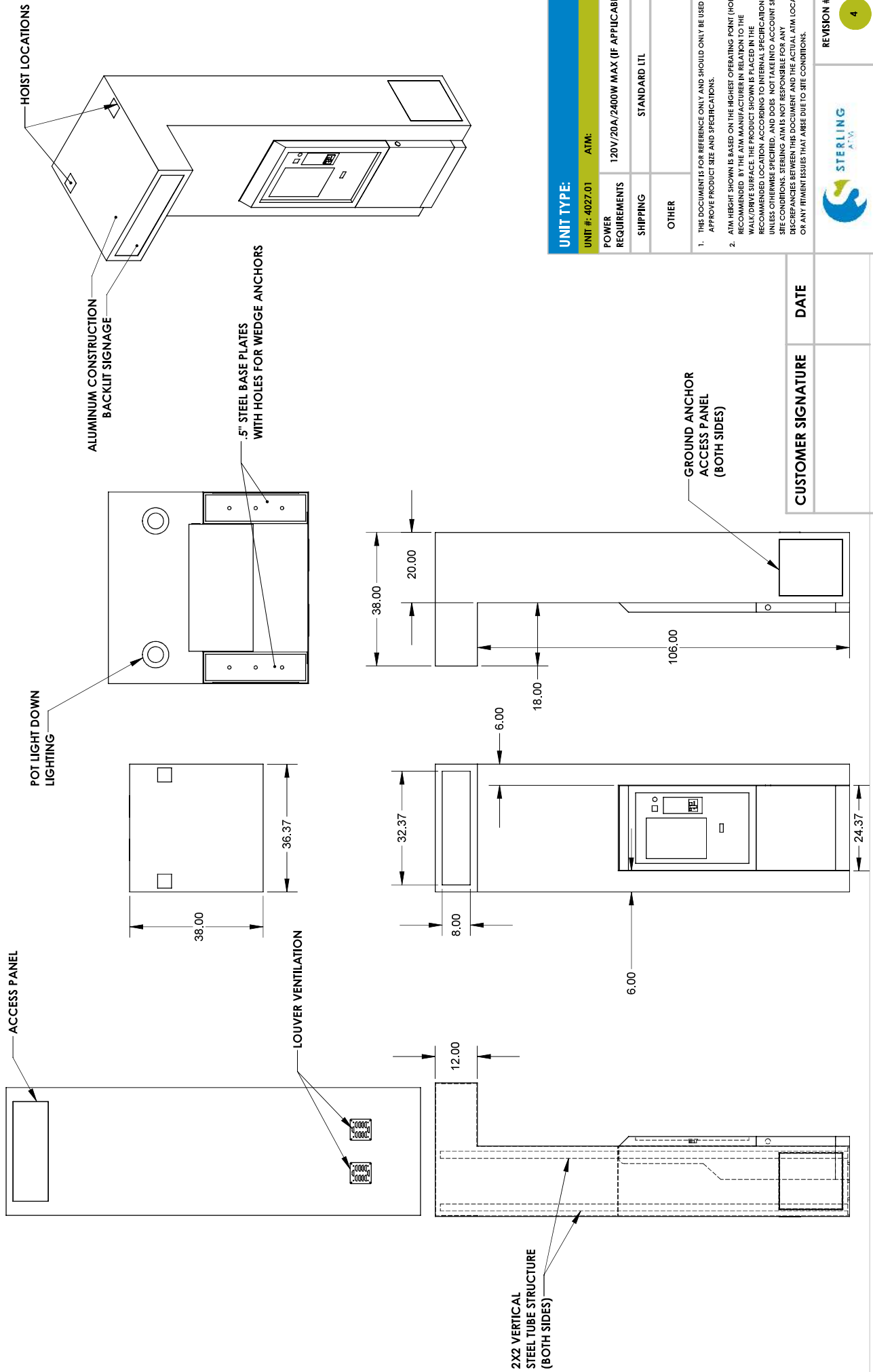

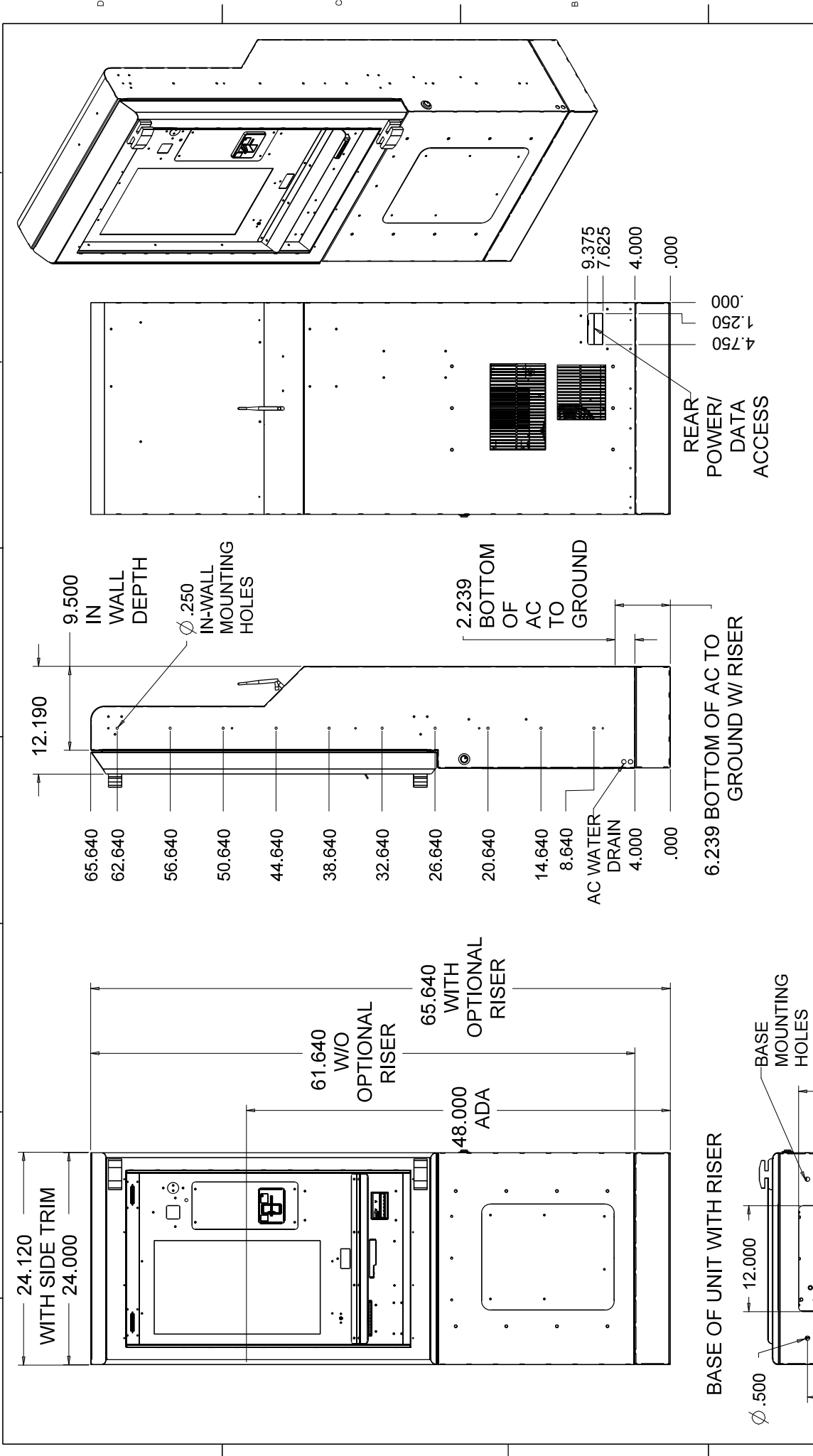

7 **WHEREAS** Section 67.040 RSMo. provides that after a budget has been approved
8 no increase in the revenues or expenditures from any fund shall be made unless the
9 governing body adopts a measure setting forth the facts and reasons making the increase
10 necessary and authorizing the increase; and

12 **WHEREAS** Section 8.7 of the City Charter authorizes the City Council to amend
13 budgeted revenues and expenditures upon the request of the City Administrator; and

15 **WHEREAS** the City Administrator has requested a budget amendment in the
16 amount of \$22,000.00, as reflected in "Council Bill Exhibit A," for the purposes referenced
17 therein; and

19 **WHEREAS** the City Council desires to amend the City's 2024 budget for the
20 purposes identified herein.

22 **NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF**
23 **NIXA, AS FOLLOWS, THAT:**

25 **SECTION 1:** The City of Nixa's 2024 Annual Budget is hereby amended in the
26 accounts and the amounts as shown on "Council Bill Exhibit A," which is attached hereto
27 and incorporated herein by this reference.

29 **SECTION 2:** City Council finds that the budget amendment enacted by this
30 Ordinance has been recommended by the City Administrator. The City Administrator is
31 directed to cause the appropriate accounting entries to be made in the books and records
32 of the City to reflect the budget amendment enacted by this Ordinance.

34 **SECTION 3:** This Ordinance shall be in full force and effect from and after its final
35 passage by the City Council and after its approval by the Mayor, subject to the provisions
36 of section 3.11(g) of the City Charter.
