

RE: 2024 Budgetary Amendment for the addition of two police officer positions and promotions

Background:

In April of 2023 the citizens of Nixa passed a ¾ cent sales tax to help fund public safety. One of the goals of this sales tax initiative was to fund additional police officers. During the 2024 budget discussions, the police department was asked to access the revenues generated by the afore mentioned sales tax after the second fiscal quarter of 2024 to determine if the addition of two more police officers' position was affordable. Based on the actual revenues generated to date, there are funds available to hire two additional police officers.

In addition to the two police officer positions, a series of promotions was also discussed. These promotions are designed to add supervision to certain levels of the organization and realign certain responsibilities and duties within the department. A total of 14 promotions will occur over the course of the next six months ranging from the Corporal position to the Captain position.

Analysis:

Because these positions and promotion will be implemented mid-year, the salary and benefits totals for the budgetary amendment were calculated for the six months of fiscal year 2024. Whereas the equipment costs were calculated based on the number of officers added. The total amount of the budgetary amendment will be \$151,472. These costs are broken down in council bill exhibit A.

The source of funding for this budget amendment is current revenues. The addition of two police officers will bring the total number of sworn police officers to 46.

It should be noted that during the first reading of this council bill the memo stated the budget amendment amount was \$151,472.00 and the attached exhibit noted \$151,572.00. There was a \$100.00 variance between the two documents. The exhibit has since been amended to reflect \$151,472.00 to match the memo associated with the bill.

Recommendation:

It is the police department staff's recommendation this budgetary amendment be approved.

AN ORDINANCE OF THE COUNCIL OF THE CITY OF NIXA AMENDING THE 2024 1 2 ANNUAL BUDGET IN THE AMOUNT OF \$151,472.00 FOR THE PURPOSE OF FUNDING TWO ADDITIONAL POSITIONS WITHIN THE POLICE DEPARTMENT. 3 4 5 6 WHEREAS Section 67.040 RSMo. provides that after a budget has been approved 7 no increase in the revenues or expenditures from any fund shall be made unless the governing body adopts a measure setting forth the facts and reasons making the increase 8 9 necessary and authorizing the increase; and 10 11 WHEREAS Section 8.7 of the City Charter authorizes the City Council to amend budgeted revenues and expenditures upon the request of the City Administrator; and 12 13 WHEREAS the City Administrator has requested a budget amendment in the 14 amount of \$151,472.00, as reflected in "Council Bill Exhibit A," for the purposes 15 referenced therein; and 16 17 WHEREAS the City Council desires to amend the City's 2024 budget for the 18 purposes identified herein. 19 20 NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF 21 22 **NIXA, AS FOLLOWS, THAT:** 23 **SECTION 1:** The City of Nixa's 2024 Annual Budget is hereby amended in the 24 accounts and the amounts as shown on "Council Bill Exhibit A," which is attached hereto 25 26 and incorporated herein by this reference. 27 SECTION 2: City Council finds that the budget amendment enacted by this 28 29 Ordinance has been recommended by the City Administrator. The City Administrator is 30 directed to cause the appropriate accounting entries to be made in the books and records of the City to reflect the budget amendment enacted by this Ordinance. 31 32 33 **SECTION 3:** This Ordinance shall be in full force and effect from and after its final passage by the City Council and after its approval by the Mayor, subject to the provisions 34 of section 3.11(g) of the City Charter. 35 36 37 [Remainder of page intentionally left blank.
