

## RESOLUTION OF THE NIXA CITY COUNCIL CONFIRMING THE APPOINTMENT OF RUTH ANN MAYNARD TO THE PLANNING AND ZONING COMMISSION

### Background:

The Planning and Zoning Commission has been one member short since Derris Butler resigned due to moving outside Nixa City Limits in April of 2024. The mayor formed an Appointments Committee in January of 2024. One of the purposes of the Committee is to interview citizens that have expressed an interest in serving on the Planning and Zoning Commission.

The Appointments Committee met May 21, 2024, and during the open meeting, nine potential appointees were interviewed by the Committee.

### Analysis:

The Appointments Committee unanimously selected Ruth Ann Maynard to serve on the Planning and Zoning Commission. Mrs. Maynard will finish out Mr. Butler's term, which will expire November 1, 2024. She will be eligible to be reappointed to serve a four-year term on the Nixa Planning and Zoning Commission at that time.

21 **WHEREAS** the Mayor, based on the recommendation of the Appointments  
22 Committee, has appointed Ruth Ann Maynard to serve until November 1, 2024; and

24 **WHEREAS** the City Council hereby consents to the Mayor’s appointment as

30 **SECTION 1:** The City Council hereby consents to the Mayor’s appointment of Ruth  
31 Ann Maynard to the City’s Planning and Zoning Commission. Ms. Maynard’s term shall  
32 expire on November 1, 2024.

35 passage by the City Council and after its approval by the Mayor, subject to the provisions  
36 of section 3.11(g) of the City Charter.
