



An Ordinance of the City of Nixa Establishing and Levying Taxes on Real Property in the City

Background:

Each year the real estate tax levy must be set for the City. To set the tax levy, the City is required to post a legal notice of the levy hearing, hold a public hearing, and pass an ordinance establishing and levying the levy. The deadline for the final certification of the levy by the Christian County Clerk is August 30th.

Analysis:

Included in your packet for review is the ordinance to set the 2024 tax levy. Also included is the 2024 assessed valuation and notice of levy hearing that was publishing in the Christian County Headliner. The anticipated levy rate for this year is 0.2981. This rate may change after the Proforma, provided by the State Auditor's Office, is completed. If approved at the August 27th Council Meeting, all required documents will be submitted to the Christian County Clerk's Office.

Recommendation:

Staff recommends approval.

1 **AN ORDINANCE OF THE COUNCIL OF THE CITY OF NIXA ESTABLISHING AND**
2 **LEVYING TAXES ON REAL PROPERTY IN THE CITY FOR THE 2024 TAX YEAR.**

4 **WHEREAS** the City of Nixa levies a general revenue property tax on all real
5 property within the city limits; and

6
7 **WHEREAS** the City is required to set the general revenue property tax levy each
8 year; and

9
10 **WHEREAS** the City advertised that a public hearing on the proposed 2024 real
11 property tax levy would be held on August 27, 2024; and

12
13 **WHEREAS** the proposed tax rates set forth herein comply with the provisions of
14 section 137.073 RSMo.

15
16 **NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF**
17 **NIXA, AS FOLLOWS, THAT:**

19 **SECTION 1:** There is hereby levied for the year 2024 a tax upon the One Hundred
20 Dollars assessed valuation on real property within or having its taxable status within the
21 corporate limits of the City of Nixa, Missouri, at the following rates and for the following
22 purpose:

24 (a) General Revenue Fund - \$0.2981.

26 **SECTION 2:** The City Clerk is hereby authorized and directed to provide a certified
27 copy of this Ordinance to the County Clerk of Christian County, Missouri. Furthermore,
28 the City Administrator and City Clerk are authorized to take any and all other actions
29 which may be necessary to carry out the intent of this Ordinance.

31 **SECTION 3:** This Ordinance shall be in full force and effect from and after its final
32 passage by the City Council and after its approval by the Mayor, subject to the provisions
33 of section 3.11(g) of the City Charter.
