### Background

As presented at the October 1<sup>st</sup> Council Budget Workshop the Parks Department proposed changes to registration fees, memberships, and other services to meet the proposed increase to minimum wage that was on the November 5<sup>th</sup> ballot. These changes in fees were formulated to account for the increased wages that the department would incur due to the minimum wage increase. At the meeting staff proposed two separate increases to take affect in January of 2025 and 2026. After much discussion it was decided that putting the increases together and only having one increase in January 2025 was the most desired plan to move forward so we hopefully do not need to increase twice in two years.

### Analysis

The increase discussed increased programming \$4.00 across the board and increased memberships \$3.00 per month or \$36.00 if paid in full. Staff has made the appropriate changes within the 2025 budget to account for this increase to revenues. As a part of changing these fees the Fee Ordinance must be updated and adopted by council to account for the new fees that will be changed beginning in January 2025.

### Recommendation

With your approval of this ordinance, we will adopt the new rates for the programs, services, and memberships described to start January 1<sup>st</sup> of 2025. We can then also follow through with the notice to our fitness membership of the increased rates according to our membership agreement. Thank you!

1 **AN ORDINANCE OF THE COUNCIL OF THE CITY OF NIXA AMENDING SECTIONS**  
2 **2-151 OF THE NIXA CITY CODE FOR THE PURPOSE OF MODIFYING USER FEES**  
3 **ADMINISTERED BY THE PARKS & RECREATION DEPARTMENT.**  
4

5 **WHEREAS** the City, through its Parks & Recreation Department operates a public  
6 park system which serves the residents and visitors of the City limits; and  
7

8 **WHEREAS** to accommodate the increasing costs of providing programs and  
9 services provided by the Parks & Recreation Department, City staff have proposed the  
10 amendments contained in this Ordinance to increase the user fees of certain programs  
11 and services; and  
12

13 **WHEREAS** the City Council desires to adopt the amendments contained herein.  
14

15 **NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF**  
16 **NIXA, AS FOLLOWS, THAT:**  
17

18 **SECTION 1:** Chapter 2, Article IV, Section 2-151 of the Nixa City Code is hereby  
19 amended as set forth in "Council Bill Exhibit A," which is attached hereto and incorporated  
20 herein by this reference.  
21

22 **SECTION 2:** Aside from the modifications described in Section 1, all other portions  
23 of Section 2-151 of the Nixa City Code shall remain unmodified.  
24

25 **SECTION 3:** Savings Clause. Nothing in this Ordinance shall be construed to  
26 affect any suit or proceeding now pending in any court or any rights acquired, or liability  
27 incurred nor any cause or causes of action occurred or existing, under any act or  
28 ordinance repealed hereby.  
29

30 **SECTION 4:** Severability Clause. If any section, subsection, sentence, clause, or  
31 phrase of this Ordinance is for any reason held to be invalid, such decision shall not affect  
32 the validity of the remaining portions of this Ordinance. The Council hereby declares that  
33 it would have adopted the Ordinance and each section, subsection, sentence, clause, or  
34 phrase thereof, irrespective of the fact that any one or more sections, subsections,  
35 sentences, clauses, or phrases be declared invalid.

37 **SECTION 5:** This Ordinance shall be in full force and effect on January 1, 2025,  
38 subject to the provisions of section 3.11(g) of the City Charter.
