

RE: RENEWING THE BASE LEASE AGREEMENT FOR REAL ESTATE AND EXISTING FACILITIES WITH THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A. FOR REFUNDING CERTIFICATES OF PARTICIPATION SERIES 2013.

Background:

Pursuant to Section 3.3 of the above referenced lease purchase agreement, an annual Ordinance is required for the renewal of the lease on the Northwest Sewer Lift Station.

Analysis:

Approval of this Council Bill will renew the terms of the lease for one year, commencing January 1, 2025, through December 31, 2025. The outstanding principal balance on this debt as of 12/31/2024 is \$55,000. The principal and interest payment included in the 2025 budget is \$55,756. This debt matures on 6/1/2025.

Recommendation:

Staff recommends passage of this bill to fulfill our requirements to our bondholder.
