5 **WHEREAS** the Nixa City Code authorizes the City to participate in cooperative 6 purchasing arrangements provided that, when a cooperative purchase exceeds 7 \$10,000.00, the purchase must be submitted to City Council for approval; and

WHEREAS City Council desires to authorize the City Administrator to utilize a
State of Missouri cooperative contract for the purchase of a traffic marking line painter for
use by the Street Department.

## NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NIXA, AS FOLLOWS, THAT:

**SECTION 1:** The City Council hereby authorizes the City Administrator, or designee, to purchase a traffic marking line painter, as described on "Resolution Exhibit A," which is attached hereto and incorporated herein by this reference. The City Administrator and the officers of the City are hereby authorized to do all things necessary or convenient to carry out the terms and intent of this Resolution.

SECTION2: This Resolution shall be in full force and effect from and after its final
passage by the City Council and after its approval by the Mayor, subject to the provisions
of section 3.11(g) of the City Charter.
